

Fibrophos Prize Draw (**Prize Draw**) Terms and Conditions

1. The promoter of this Prize Draw is Gleadell Agriculture Limited (a company registered in England and Wales with company number 00534118), whose registered office is at Lindsey House, Hemswell Cliff, Gainsborough, Lincolnshire, DN21 5TH (**Gleadell**).
2. These terms and conditions are the Prize Draw rules (**Rules**). By entering the Prize Draw, entrants agree to be bound by these Rules.
3. Gleadell reserves the right to cancel the Prize Draw or amend these Rules at any time without prior notice.
4. In the event of any dispute regarding the Rules or the Prize Draw, the decision of Gleadell shall be final and no correspondence or discussion shall be entered into.
5. To qualify to enter the Prize Draw the entrant must be 18 years old and resident in Great Britain (excluding Northern Ireland) and must purchase one load of Fibrophos or P-Grow fertiliser from Gleadell (every load purchased will automatically receive one entry into the Prize Draw).
6. The Prize Draw will run from 6th August 2015 until midnight on 31 October 2015 (**Closing Date**). Entries received after the Closing Date will not be entered into the Prize Draw.
7. Employees of Gleadell or any group company or any company, organisation or body involved in the Prize Draw or any members of any employees' families or households or any other persons directly or indirectly connected with the Prize Draw are not eligible to enter the Prize Draw. Gleadell reserves the right to verify the eligibility of all entrants.
8. To enter the Prize Draw entrants must purchase at least one load of Fibrophos or P-Grow fertiliser by calling a Gleadell farm trader or the Gleadell fertiliser desk on 01427 421237. Entrants will be required to provide their name, address and email address. Once entrants have entered the Prize Draw, any copyright in the entry will be owned by Gleadell.
9. By entering the Prize Draw, the entrant hereby warrants that all information submitted by the entrant is true, current and complete.
10. Gleadell assumes (and the entrant warrants) that by entering the Prize Draw, the entrant has legal capacity to enter the Prize Draw and agrees to the Rules (i.e. that the entrant is of sufficient age and mental capacity and is capable of being legally bound in contract).
11. Gleadell reserves the right to disqualify any entrant if it has reasonable grounds to believe the entrant has breached any of the Rules.
12. Entry is free but entrants should be aware that they may be subject to charges depending on their own individual arrangements for telephone charges (as applicable).
